## What You Need to Know about Overdrafts and Overdraft Fees

An <u>overdraft</u> occurs when you do not have enough money in your account to cover a transaction, but we pay it anyway. We can cover your overdrafts in two different ways:

- 1. We have <u>standard overdraft practices</u> that come with your account.
- 2. We also offer <u>overdraft protection plans</u>, such as a link to a savings account (Overdraft Sweep) or to a Consumer line of credit (subject to credit underwriting guidelines) which may be less expensive than our standard overdraft practices. To learn more, ask us about these plans.

This notice explains our standard overdraft practices.

## ▶ What are the standard overdraft practices that come with my account?

We do authorize and pay overdrafts for the following types of transactions:

- Checks and other transactions made using your checking account number
- Automatic bill payments

We do not authorize and pay overdrafts for the following types of transactions unless you ask us to (see below):

- ATM transactions
- Everyday debit card transactions

We pay overdrafts at our discretion, which means we do not guarantee that we will always authorize and pay any type of transaction.

If we do not authorize and pay an overdraft, your transaction will be declined.

#### ▶ What fees will I be charged if Exchange Bank pays my overdraft?

Under our standard overdraft practices:

Account Number:

We will charge you a fee of \$35 each time we <u>return</u> an item that overdraws your account. We will charge you a fee of \$35 each time we <u>pay</u> an item when your account is more than \$20 overdrawn that business day. In addition, if your account is overdrawn for 5 or more consecutive business days, we will charge an additional \$25 every 5th business day as a Continuous Overdraft Charge. The daily limit your account can be charged for overdraft fees (excluding Continuous Overdraft Charge) is \$140 per business day. There is **no limit** on the total fees we can charge you for overdrawing your account.
